NIH Salary Cap:

For FY 2012, the Consolidated Appropriations Action, 2012 (Public Law 112-74) signed into law on December 23, 2011 lowered the salary limitation on NIH Grants from Executive Level I (\$199,700) to Executive Level II (\$179,700). This change is effective with grant awards with an Initial Issue Date on/After 12/23/2011. See NIH Guide Notice NOT- OD-12-035 for additional details.
